- 3. Have a minimum of 3 industry related references.
- 4. References should reflect a history of more than 24 months of purchasing background.

Unacceptable credit references include:

- 5. Mike & Jerry's Paint and Supply's open account terms are <u>Net 10th</u>. All accounts which are more than **30 days** past due shall incur late charges computed at a rate of **1 1/2% per month** on the unpaid balance.
- 6. In case of any litigation concerning this account, all litigation will be held in **Jefferson Parish, Louisiana.**
